For suppliers: greater visibility, increasing the likelihood of being selected for projects and integrated into robust design and procurement strategies.


As demand for efficient, productive and high-quality solutions grows, we expect **Verified by Cast** to continue expanding by:



The logo is specific to the year of Verification, and a new logo will be issued subject to renewal and successful re-verification in future years.

The initial set of pass/fail criteria and other factors that will be included as part of the process are set out below. This is correct as at March 2025.

The verification process

Step one: Application



Up to one week

- The fastest and simplest way to start the process is to visit www.cast-consultancy.com/verified/#kopeform and complete the form
- The team at Cast will contact you to organise a thirty minute video call to outline the process in more detail and confirm the minimum requirements for the Verification
- We'll issue a form and the first invoice, for the non-refundable part of the fee: £1,500

Step two: Verification



Typically two weeks

- On confirmation of payment we will commence the verification process
- We will issue a request for information document and will engage with you and your team to ensure we have the correct information
- We will get back in touch if we have any questions or concerns
- We will contact the client whose details you have supplied to confirm their testimonial

Step three: Profile updated and Verification badge issued



Typically one week

- Subject to successful verification, we will commence the final stage of the exercise
- We will issue a second invoice for payment of the final £1,500
- We will update your profile listing on KOPE market
- We will liaise with you and your team to ensure your company is presented in the best possible manner
- On completion of the above, and confirmation of final payment, we will:
 - » Show your company as **Verified by Cast**
 - » Announce that your company is Verified on Cast social media
 - » Link to your company's case study on the Cast website
 - » Issue the **Verified by Cast** digital assets for use on company materials and PR

Note:

The Verification is an annual process, with an annual fee.

We will contact Verified suppliers three months before their **Verified by Cast** status expires to discuss re-verification.

The payment does not automatically renew, and will only be charged where suppliers or specifiers wish to remain as Verified Suppliers or Specifiers for a further year.

Contract terms and conditions*

Fee and payment

Verified by Cast is priced at £3,000 per year. This is billed in two instalments – first, a £1,500 non-refundable deposit which covers the cost of the initial verification activity and second, a £1,500 final payment once verification has been confirmed.

Commencement and term

The agreement lasts for 12 months and automatically terminates unless renewed in writing three months before the end of the term.

Supply of services

Cast will provide the Subscription Service from the Effective Date and any Additional Services as agreed. Cast has sole discretion over the **Verified by Cast** process and can terminate the agreement if the customer fails this process. Cast will perform services with reasonable care and comply with laws, and can revoke the customer's Verified Supplier status without notice if criteria are not met.

Customer's obligations

The customer must cooperate with Cast, provide accurate materials, and comply with laws. The customer is responsible for their materials and must indemnify Cast against any related losses. If the customer delays Cast's performance, Cast is not liable for resulting costs and is entitled to payment and recovery of additional costs.

Data protection

Both parties must comply with Data Protection Legislation, ensure data security, and cooperate in case of data breaches.

Intellectual property

Cast retains ownership of its intellectual property, and the customer retains ownership of its materials. Cast grants the customer a limited license to use Cast's intellectual property for internal business purposes during the agreement term.

Charges and payment


The customer must pay Cast in instalments, with 50% due at the start and 50% upon passing the **Verified by Cast** process. Additional charges are payable as agreed, and all payments exclude VAT. If the customer fails to pay on time, interest will accrue, and Cast may suspend services.

Limitation of liability

Cast's liability is limited to the charges paid by the Customer in the preceding 12 months, excluding indirect or consequential losses. Liability for death, personal injury, fraud, and breach of title and quiet possession is not limited.

Termination

Either party can terminate the agreement immediately with written notice if the other party breaches the agreement or faces insolvency issues. Upon termination, the customer must pay outstanding invoices, cease using Cast's intellectual property, and lose Verified Supplier or Specifier status.
